Dear Sirs,

This is an open letter from concerned First Nations, supported by community and conservation groups, written as a courtesy to your companies to warn you of the growing opposition to the siting of the proposed Pacific Northwest LNG project.

In their eagerness to attract your investment dollars to British Columbia, our federal and provincial governments have failed you, much as they have failed Canadians. In your case, they have downplayed your investment risk. In our case, they have downplayed the social and environmental risks. We cannot estimate the extent of the investment risk you are prepared to take, but we can assure you that the social and environmental risks your project poses to our communities are utterly unacceptable.

It cannot have escaped your attention that the 190 conditions that our government has placed on your project prompted Eurasia Group, a New York-based political risk assessor and a disinterested party, to judge those conditions as onerous compared with the regulatory constraints that your competitors face elsewhere. This, after a lengthy permitting process that was so flawed that we are considering legal actions to have your project's approval overturned on the basis of procedural errors on the part of the Canadian Environmental Assessment Agency and the federal Crown.

The federal and provincial governments have misled you into believing that your project has broad public support, including what B.C. Premier Christy Clark claims is the "overwhelming support" of affected First Nations people in the region. That is not the case. A recent Federal Court of Appeal decision found that Enbridge and the federal government did not adequately consult and accommodate First Nations people with respect to the proposed Northern Gateway

pipeline project in our region. This resulted in the removal of their Environmental Assessment Certificate. We will also seek recourse through the UN Permanent Forum on Indigenous Issues.

Another domain where our governments have exposed your project is in the matter of the greenhouse gas emissions that PNW LNG will produce. The contradiction between the federal government's conditional approval of your project, and its demand that our House of Commons ratify the Paris climate change accord, is not lost on Canadians. These are incompatible actions that can be resolved by stopping your proposed project. We vow to take domestic and international actions to hold our government accountable to its climate change commitments, which cannot accommodate approval of your proposed project - which would be one of the single largest climate polluters in our country.

Finally, the federal and provincial governments have advanced a fiction – despite peer reviewed, independent science to the contrary – that the risks to our precious salmon habitat in the Skeena River estuary can somehow be "mitigated". We rely not just on Western scientific opinion, but on our traditional scientific knowledge in judging your proposed project to be reckless in the extreme, posing unacceptable risks to salmon – a staple not just of our diet, but of our culture. We have concluded, the only acceptable "mitigation" to threats to our salmon resources is to prevent your proposed project from proceeding.

In that light, let us close with reference to the "final investment decision" that you are contemplating making in the coming weeks or months. You are perfectly at liberty to make whatever decision you want, but understand that we have made a final investment decision of our own. Our decision is to stop the Pacific Northwest LNG project, which undermines First Nations rights, weakens our cultures, accelerates climate change, and directly threatens our most precious resource – our salmon. Our final investment decision is to invest in the protection of our salmon for future generations, and to support industry and development that is compatible with that fundamental goal.
